**Canada's Border Security Agency** is responsible to ensure compliance with importers & exporters. One of these methods is by performing random and prioritized verification type audits. Each January & July specified commodities are identified for audit and are made public by the CBSA. Certain products are chosen for review of tariff classification, while others are based on validation of their values or origins & free trade certification.

If your company receives a phone call or letter from CBSA, it is recommended you notify your Customs Broker as soon as possible. Your Customs Broker will not be made aware that you have been chosen for audit. Your Customs Broker cannot act on your behalf until you have signed the Letter of Authorization that accompanies CBSA's initial package.
