Canada Customs Trade Compliance Audit Targets Revised July 2026



Canada's Border Security Agency is responsible for ensuring compliance by importers and exporters. One of these methods is by performing random and prioritized verification-type audits. Each January and July, specified commodities are identified for audit and are made public by the CBSA. Certain products are chosen for review of tariff classification, while others are based on validation of their values, origins & free trade certification. In addition, because of the ever-changing trade environment, GST, Tariff quotas, and Trade Relief programs have been added to their targets.

CARM (CBSA Assessment Revenue Management) is now being utilized to validate duties & taxes and conduct compliance interventions of known or suspected non-compliance. CBSA has also introduced 3 additional intervention tools to assist them in their audit of circumstances & risks of non-compliance. These additional tools do not replace current verification methods.

If your company receives a phone call or letter from CBSA, it is recommended you notify your Customs Broker as soon as possible. Your Customs Broker is not aware you have been chosen for audit and cannot act on your behalf until you have signed the Letter of Authorization that accompanies CBSA's initial package.
